Transition Towns

It all starts off when a small collection of motivated individuals within a community comes together with a shared concern: how can our community respond to the challenges and opportunities of peak oil and climate change?

They begin by forming an 'initiating group' and then adopt the 'Transition Model' with the intention of engaging a significant proportion of the people in their community to start a 'Transition Initiative'.

We are convinced that:

- if we wait for the governments, it'll be too little, too late
- if we act as individuals, it'll be too little
- but if we act as communities, it might just be enough, just in time.
