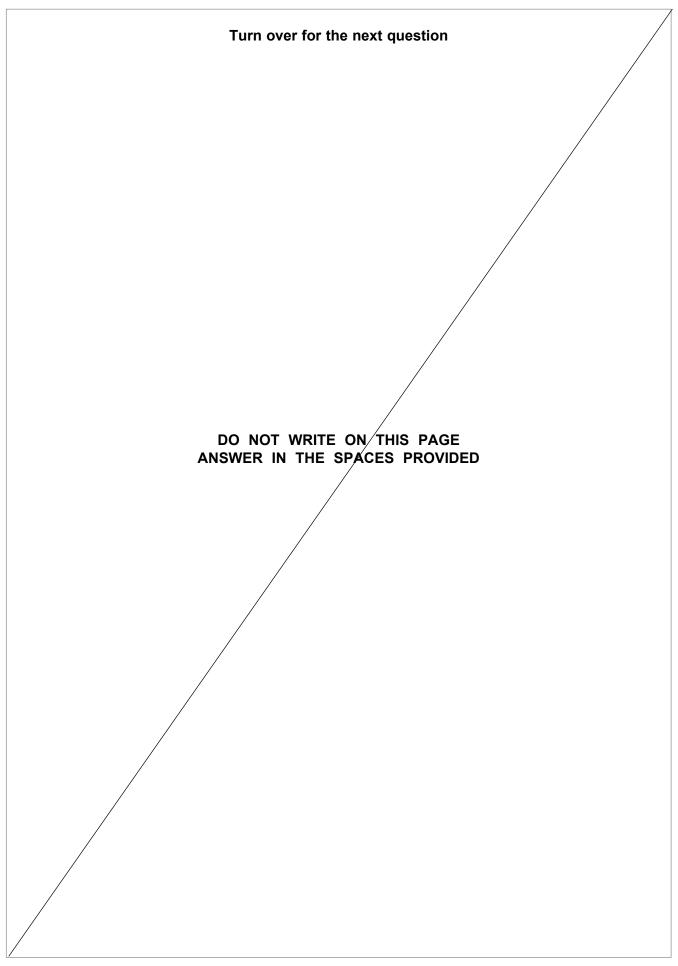

# Answer Questions 1 to 3.

#### Questions 2 and 3 are based on the following scenario:

Suppose that the Government has placed a new Bill before Parliament to make further major changes to the National Health Service (NHS). It has sharply divided public opinion. Some of the Government's own backbench MPs are threatening to vote with the Opposition, making it possible that the Bill will be defeated. With a General Election on the horizon, that would be serious.

The Government's options are

- [1] to propose the Bill without any amendment
- [2] to amend the Bill to make some concessions to its opponents
- [3] to withdraw the Bill completely.

Government advisers have warned the Government of the following possible consequences, and their estimated probabilities.

### Option [1]

The worst case scenario is *defeat* for the Bill in the House of Commons. The probability of this is thought to be no more than 0.2 (1 in 5, or 20%). But the consequences would be serious: equivalent to a loss of up to 10 points in the polls – enough to lose the next General Election.

Even if the Bill is *passed* by Parliament, it is still expected to be deeply unpopular with the voters. A drop of 8 points in the polls is predicted with 0.6 (60%) probability. This leaves a 0.4 (40%) chance of more moderate opposition, leading to a fall in the polls of around 4 points.

## Option [2]

If the Bill is amended there is no risk of defeat in the Parliamentary vote, but it is unlikely that the electorate will be satisfied. A drop of 7 points in the polls is thought to be 70% probable, and a drop of 4 points to be 30% probable.


#### Option [3]

This would have only one predictable outcome: a humiliating U-turn, with an expected fall of around 5 points in the polls.
