Question 1

Study the following source material and then answer the questions which follow.

Source A

Source C

There can be no simple assessment of Peter's reforms. His administrative reforms were not fundamentally radical. Although he borrowed ideas from the West, he also maintained part of the old Russian system. His economic policies produced spectacular industrial advances, but he did nothing to prevent the development of an unbalanced economic structure. Peter's reign had little lasting impact on the class structure; the emancipation of the nobility was only temporarily interrupted and the enslavement of the serfs continued. As far as the Church was concerned, the period can be seen as a turning point, for it was Peter who ended its independence.

0 5 Explain why, in 1698, Peter the Great ordered the abolition of the Streltsy regiments. (12 marks)

and

'The most serious opposition to the rule of Peter the Great after 1698 came from Tsarevich Alexis.'

Explain why you agree or disagree with this view. (24 marks)
