- (b) Briefly examine the role of the jury in a "jury trial" (Source A). (10 marks)
- (c) Assess the advantages **and** disadvantages of having cases heard by a single District Judge with greater powers than those of lay magistrates. (16 marks)

- 2 (a) "The relationship between the citizen and the state should be based on freedom of information."

  Briefly discuss this view. (10 marks)
  - (b) Assess the view that the Citizen's Charter has had no significant impact on people's day-to-day lives. (20 marks)

- 3 (a) Briefly examine how institutional racism can deprive some citizens of their rights. (10 marks)
  - (b) Assess the view that active citizens should be as concerned with duties as with rights. (20 marks)
