As part of the UK government's ongoing policy to reduce its debt and borrowing, the Chancellor of the Exchequer has announced that the grant to local councils will be cut. This cut will be 15% next year and a further 15% the following year.

The Chancellor said, "All aspects of government spending have been facing cuts: local government and its services cannot be exempt."

Source B**Council protests at scale of cuts**

A Local Government spokesperson on behalf of all local councils stated, "These cuts will have a devastating impact upon both services and employment within local government. We are unable to raise council tax to make up this loss and over 60% of our income comes from central government grants. These cuts will be deep and impact upon all local government services. They will damage our ability to provide services to the vulnerable and those in need, especially the young and the elderly. Many councils will have to review thoroughly how they deliver their services. This could lead to many front-line workers in local government losing their jobs. Local people rely upon their local councils to meet many of their everyday needs."

A County Court judge has decided that a woman was charged thousands of pounds by her credit card company for an insurance policy she never asked for. The woman said she was treated badly by the company: "I ticked 'no' on the insurance option box but the company took the money anyway." The company also kept increasing her credit limit. The company took the woman to court for her credit card debt of over £8000. The judge decided that the insurance charges had been unfairly imposed and threw out the rest of the company's case against the woman.

Three brothers who earned the nickname of 'The Asbros' after terrorising their neighbours for years have finally been jailed for stealing a car to celebrate New Year.

The brothers plagued their neighbours for years with abuse, violence, drugs, assault, intimidation, theft and vandalism.

The brothers have appeared in court many times for dozens of offences and have been given multiple Anti-Social Behaviour Orders (ASBOs).

The three brothers were jailed for a total of 31 months after they admitted other offences at the Crown Court.

The judge said, "You showed no understanding or recognition of the impact on your victims. The courage of the members of the public who volunteered to give evidence against you needs to be recognised."

She also thanked the jury, made up of local people, for doing their civic duty.

5 Global Issues and Making a Difference – International conflict and its resolutionRead **Sources G** and **H** and answer parts (a), (b) and (c) which follow.**Source G****The United Nations and peacekeeping**

The first United Nations (UN) peacekeeping mission was in 1948. Since then, there have been 63 UN peacekeeping operations around the world. It was set up to deal with inter-state conflicts. It now finds itself dealing mostly with civil wars. Although military forces are involved, these operations now also involve administrators, economists, police officers, legal experts, human rights and election experts.

Source H**The war in Afghanistan**

There are currently nearly 150 000 foreign troops under NATO and US command, supporting the western-backed Afghanistan government, army and police forces. These troops are involved in fighting the Taliban and its supporters.

Recent elections held in Afghanistan were heavily criticised as vote-rigging was alleged.

President Obama recently visited the country and told the government that much of the corruption and financial mismanagement within the government and at a local level had to stop.

America first sent troops to Afghanistan to overthrow the former Taliban government for its support of terrorist groups associated with the 9/11 attacks in America.

The foreign troops are also assisting with the reconstruction of the country.

Some countries are now reducing their troop commitment or withdrawing their troops altogether. In many countries, there are active campaigns to seek the withdrawal of foreign troops from Afghanistan.
